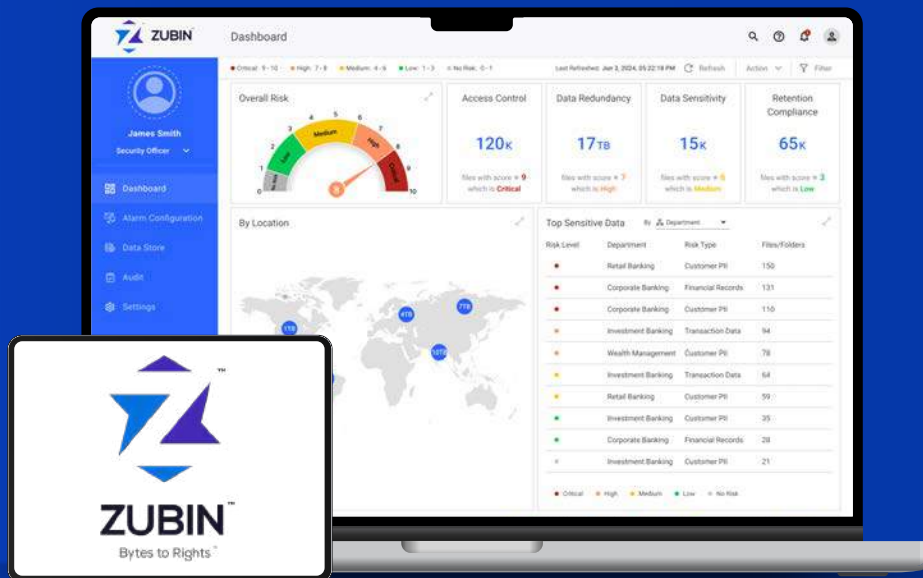

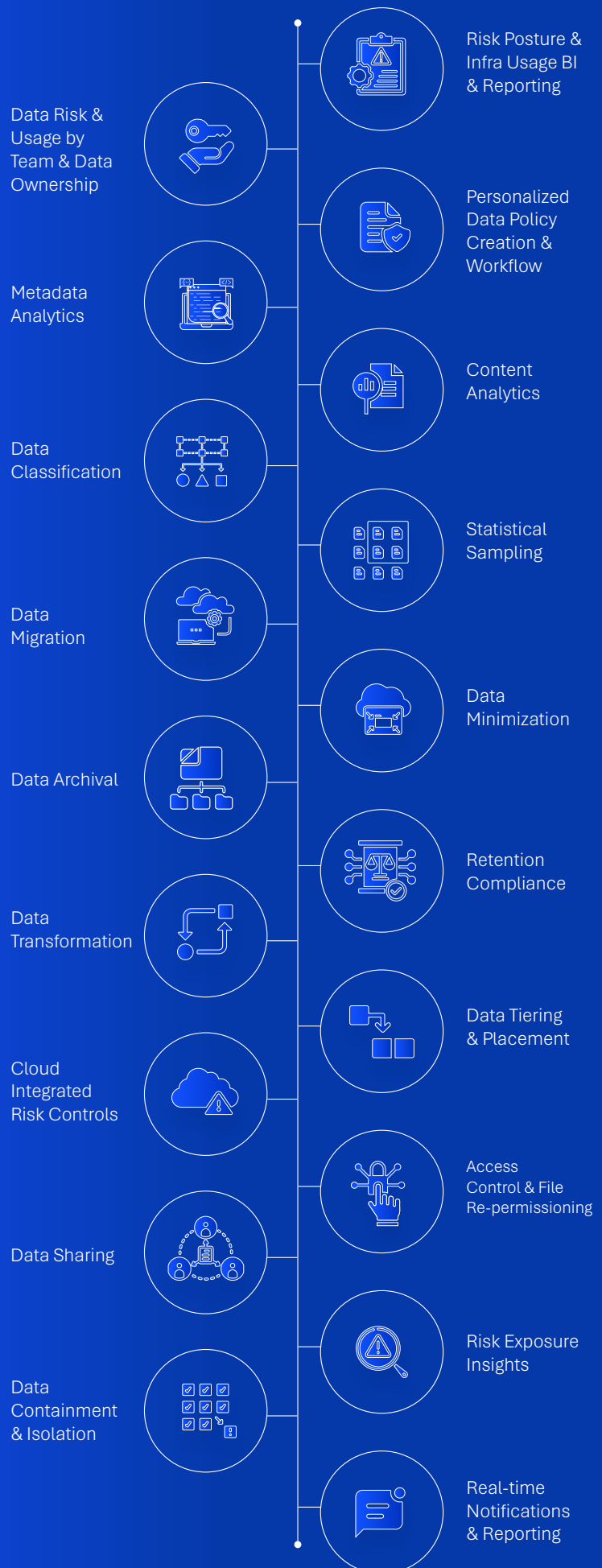

This translates to business continuity and adherence to compliance regulations that require data availability and disaster preparedness.

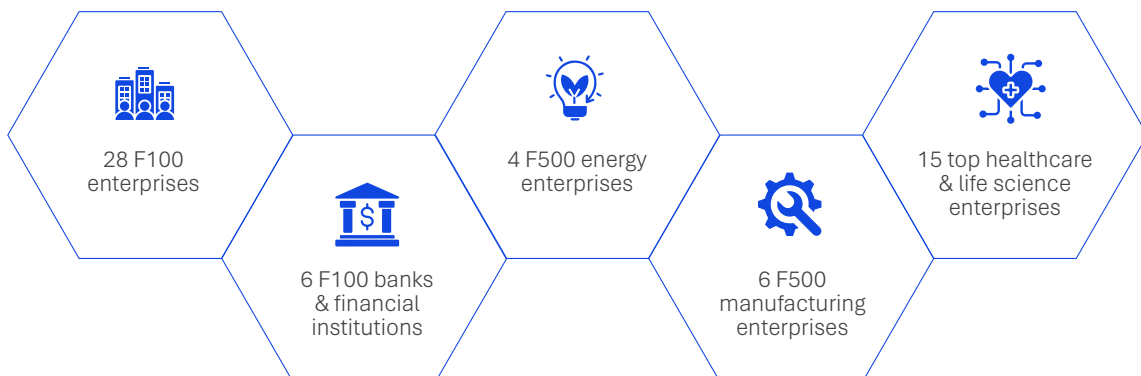
