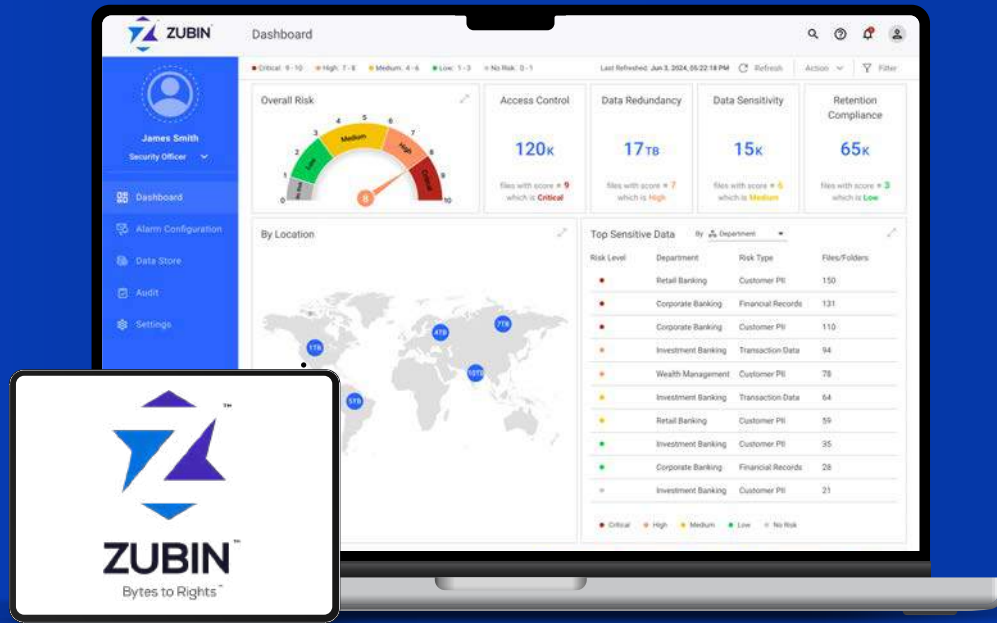

Data Security Orchestration, Automation, and Actionability

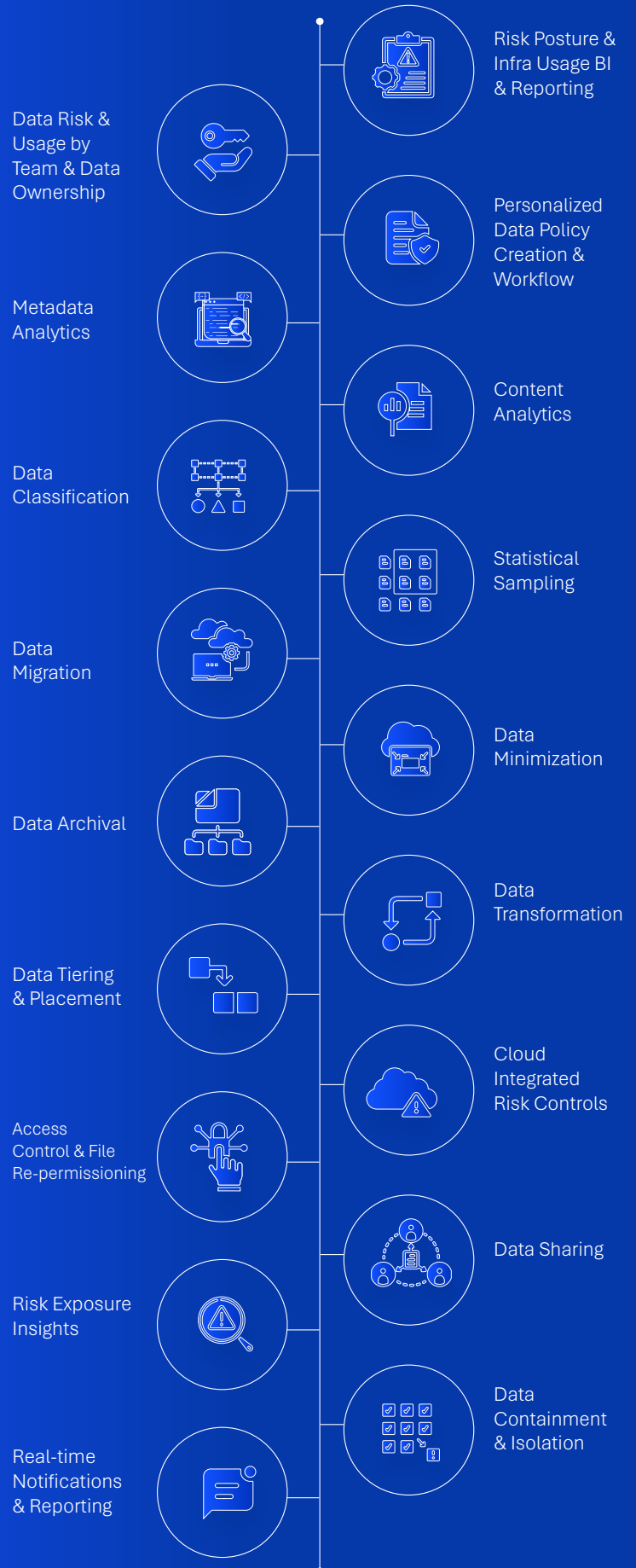

Foundations for Robust Security and Scalability

- **Microservices Architecture:** Utilizes a modular, containerized architecture for independent deployment and scalability. Communication between these microservices occurs through a lightweight API gateway, promoting efficient resource utilization and fault tolerance.
- **Centralized Access Control:** Enforces RBAC through a centralized authorization server, ensuring only authorized users can access specific data. Industry-standard algorithms are used to encrypt data at rest and in transit, providing additional protection.
- **Multi-Layered Encryption:** Supports multiple data encryption algorithms to ensure data confidentiality at rest and in transit.
- **Automated Management and Scalability:** Container orchestration automates deployment and scaling, ensuring smooth operation and efficient resource utilization. Additionally, the horizontal scaling of the distributed architecture allows Zubin to handle increasing data volumes securely.
- **Unstructured Data Processing and Threat Detection:** Incorporates a hub-and-spoke architecture, leveraging a single central Zubin instance with scalable UDE (execution engines) to provide performance at scale. This includes metadata & content processing and analysis of unstructured data of over 250+ diverse data formats within emails, multimedia, presentations, and various document types, allowing users to analyze diverse data formats for valuable insights.
- **High Availability and Disaster Recovery:** Employs strategies including data replication, geo-clustering, and failover mechanisms to minimize downtime and ensure continuous data access in case of failures, improving overall system resilience.

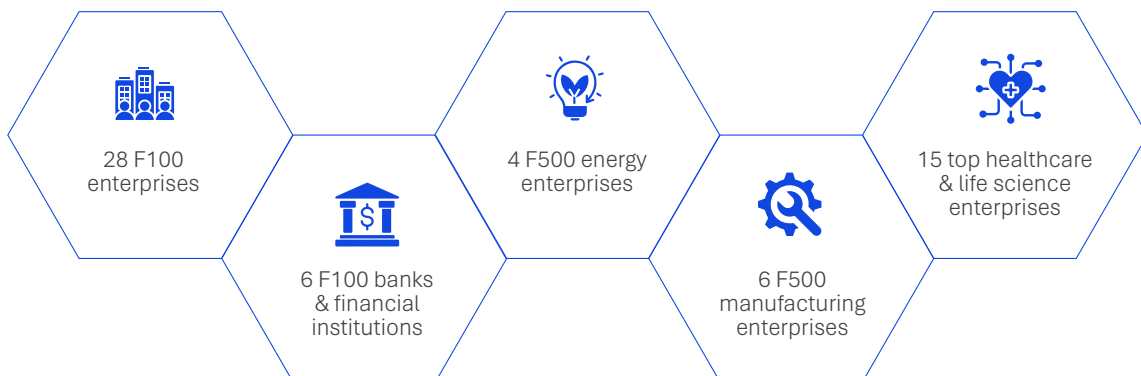
