- Supported storage resources include Windows and Linux, Data ONTAP, VNX OE for File, OneFS, CIFS/NFS client computers, IBM Cloud Object Storage, StorageGRID and S3compliant object storage.
- Visualize file storage infrastructure relationships from Namespace, File Server, shares, exports, volumes, qtrees, folders, to individual files or S3 buckets to individual files.
