## Business Challenge

StorageX Retrieval Portal is used to find and retrieve archived data on the S3-compliant object storage resource(s) to which you have access. StorageX supports direct access using standard S3-compliant software tools. In lieu of the StorageX Retrieval Portal, you can access your S3 Objects directly using S3-compliant software.

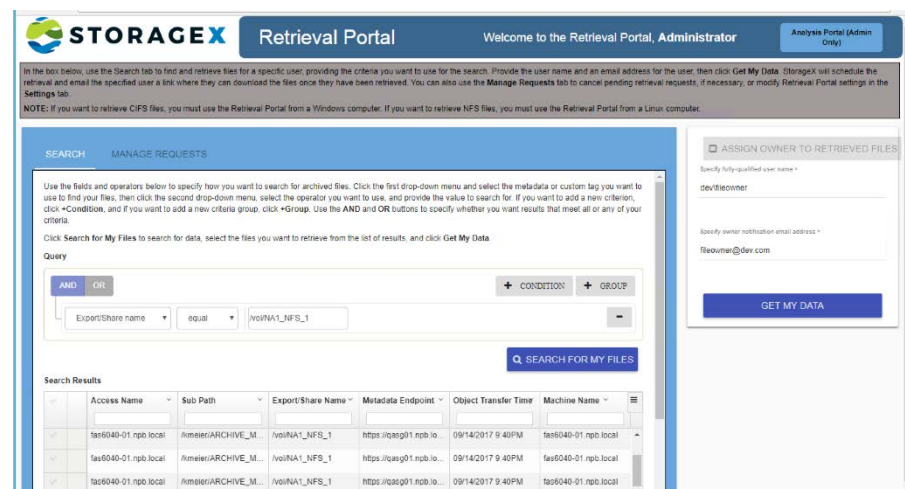
- The StorageX Retrieval Portal is a S3-compliant web-based application admins can use to search and retrieve file objects from object storage.
- Save files back on local file share for audits and legal discovery.
- Directly access your object files using any S3-compliant browser.
- Program custom applications to read files using a S3-compliant REST API.
- At no time, do you incur license fees to read your archive files.
